If a question comes up, proof of contestant Driver's License and contestant parents' Driver's License will be required.

The winner will be required to attend the week of the Mercer County Fair events, KY State Fair Opening Day ceremony and assist with the Little Miss and Mr. KY State Fair Pageant. Also, the winner will represent the Mercer County Fair in the KY State Fair Pageant in January held in Louisville. For any reason the winner can't attend, the first runner-up will represent the fair.
